

# **Agreement for Quality Assurance**

#### A. Scope

This agreement rules the measures for the quality assurance for the collaboration between the supplier and Kubo Tech AG.

It aims to guarantee the supply of the required quality at minimized costs. Another objective is that no more technical testing at goods receiving department of Kubo Tech AG is necessary. The incoming inspection will be restricted to checking of quantity, accuracy of the consignment and damages occurred during transportation.

This is an important prerequisite for a successful collaboration in terms of profitability and quality assurance.

### **B.** Applicability / Quantity Tolerances / Inspection Sheets

#### 1) Products

This quality assurance agreement is valid for all products listed in Appendix 1.

#### 2) Quantity tolerances

Short shipments shall not be accepted. An over delivery of max. 5% of the order quantity is accepted.

### 3) Inspection Sheets

The inspection sheets are archived at the supplier's premises for 10 years. Copies of the test reports are generally included.
